

Youth Opioid Response California 3 Funding Awards Released

The California Youth Opioid Response (YOR California) is pleased to announce 43 grant awards for the third round of State Opioid Response (SOR) funding of \$12 million, subsequent to a statewide RFA process, and over 70 applications.

YOR California seeks to strengthen capacity and access to prevention, treatment, and recovery services, as well as access points to Medication-Assisted Treatment, for youth (ages 12-24) and their families. This opportunity is also designed to foster the creation, coordination and strengthening of local level multisystem networks and to encourage the development of new partnerships between agencies that touch youth.

YOR California is a partnership between the California Institute for Behavioral Health Solutions and Advocates for Human Potential, Inc. Since its inception, YOR California has provided \$34,000,000 including this round, in funding to organizations throughout California, spanning the continuum of prevention, intervention, treatment and recovery services for youth.

YOR California is supported by federal State Opioid Response funds through a grant provided by the California Department of Health Care Services.
